Read: Minutes of the meeting held by the Honourable Minister for Finance on 28.7.2007 at Collectorate, Palakkad.

### **ORDER**

The Hon'ble Minister for Finance has declared in the Assembly an action plan to improve the efficiency of the Commercial Taxes Check Posts. To begin with, Check Posts functioning in Palakkad district, the gateway of Kerala are selected for implementing the first phase of the action plan. The aim of the Special drive is to enhance the overall efficiency in the check posts and to step up the tax collection. The procedural formalities in the check posts shall be streamlined so that no Goods carrier with full and vivid documents shall be laid up in the check posts for more than two hours. The documents shall be electronically recorded and transferred to the respective offices then and there. This will enable the concerned officers in various districts / circles to cross check with the returns filed by the traders. This will definitely enhance efficiency and step up tax collection. The smooth traffic, transparent transfer of records, periodic reviews and social audit shall certainly bring down corruption. On successful completion of the special drive, it is envisaged that certain standard can be fixed and the model can be replicated elsewhere.

2) In the meeting held by the Honourable Minister for Finance on 28.7.2007 at Palakkad with officials of Commercial Taxes Department and various other Departments, it was decided, interalia, to overhaul the entire system of operation of the Check Posts and Intelligence Squads in Palakkad district for the above purpose. The modalities are also

worked out in detail. To make the operations a success as envisaged, improvement in infrastructure is essential. This requires the cooperation of many other departments like Public Works, Local Self Govt., Home, Excise, Transport, BSNL, KITCO, Nirmithi Kendra, etc. The suggestions in the meeting have been examined in detail and Government are pleased to approve the following measures to improve the infrastructure of the Check Posts to be undertaken by the agencies/departments concerned within the time frame mentioned therein.

#### **i) National Highway Walayar**

The Assistant Executive Engineer, PWD, Palakkad will submit an estimate for pothole filling of the NH stretch from Kerala border to the entrance of the OUT Check Post, Walayar. He will also submit a detailed estimate for full maintenance of the same stretch for consideration (7 days time).

#### **ii) Lighting in Walayar Check Post**

- a) Malabar Cements will permit KSEB to draw power from their dedicated line to the Check Post by using overhead lines and an underground cable connection. The Commissioner of Commercial Taxes will pay the cost (tentatively Rs. 15 lakhs) to KSEB for the purpose.
- b) KSEB will undertake immediate maintenance work for their transformers yard at Walayar and to change the service wire to 50mm<sup>2</sup>.
- c) KITCO will immediately make estimates for upgrading the power wiring and taking additional load from KSEB and the Commissioner will sanction the same immediately.
- d) Malabar Cements will put up lights along the National Highway upto Walayar OUT Check Post meeting all the initial capital cost.
- e) The recurring monthly power bills will be paid by Pudussery Panchayat.

### **iii) (a) Civil Works**

Nirmithi Kendra will complete the works in Velanthavalam quarters within 10 days and the work in Gopalapuram and Govindapuram quarters in 30 days.

(b) PWD (buildings) will return the Rs. 4 lakhs deposited with them for repair works of Meenakshipuram and Naduppunni CTCP quarters on 26.3.2006 immediately and the work will be done by Nirmithi Kendra; they will send the estimate for the same immediately. Nirmithi Kendra will put up a cabin near the entrance at IN Check Post, Walayar in **five days** time.

(c) The Weigh Bridge at Walayar will be got lifted by the rate contractor SILK immediately and the area will be leveled by KITCO for use as parking area.

(d) KITCO will complete the cleaning and leveling of unused area at Walayar IN Check Post in **three days** time and make the area suitable for holding the inaugural function. They will also make the area suitable for parking detained vehicles in 30 days time.

(e) Pudussery Panchayat will take up cleaning of drains in Walayar Check Post immediately and complete in **30 days time**.

### **iv) Law and order**

The District Superintendent of Police will make adequate arrangements for maintaining law and order in the Walayar area and for traffic control there, deploying only young recruits from the AR camp. He will also instruct them to abide by parking regulations in the Check Posts.

### **v) Stamping of Cargo vehicles**

The Excise Check Post Walayar will ensure that documents of all cargo vehicles are stamped before they move on to the Commercial Tax Check Post at Walayar.

They will be provided additional space subject to availability adjacent to their existing shed by shifting the generator.

**vi) Weigh Bridge at Motor Vehicles Check Post, Walayar**

Immediate steps will be taken by Motor Vehicle Check Post at Walayar for operationalising their weigh bridge by purchasing the necessary equipment of the OUT Check Post, Walayar. They will also submit a detailed estimate for full maintenance of the same which will be accorded special sanction. The Motor Vehicles Department will furnish proposals to Government in this regard.

**vii) (a) Shifting of Check Post**

Velanthavalam Check Post stands shifted to Kozhippara junction as there is more space for inspecting vehicles.

(b) The Vadakarapathy Panchayat will release the structure built under the MLA scheme for use of the Check Post and the Panchayat will be compensated by the State Government to the extent of the cost of the building separately.

**viii) Toll-free public phone**

BSNL will make available toll-free public phone at Walayar Check Post. They will also cooperate for speedy implementation of the WAN of the department.

**ix) Sign Boards**

- (a) Commissioner of Commercial Taxes will design and set up along the roadside from Kerala State border till the OUT Check Post at Walayar, suitable sign boards for guidance of drivers.
- (b) KITCO will set up immediately a huge billboard along the compound wall of the Check Post at Walayar for displaying suitable messages.

3) The Commissioner of Commercial Taxes will organize a study of the procedure at Check Post and devise suitable improvements on an immediate basis.

4) The Departments concerned will take immediate action to implement the above measures so as to improve the efficiency of the Check Posts in Palakkad district and to make them hassle-free and people friendly.

### **ORDER**

The Hon'ble Minister for Finance has declared in the Assembly an action plan to improve the efficiency of the Commercial Taxes Check Posts. To begin with, Check Posts functioning in Palakkad district, the gateway of Kerala are selected for implementing the first phase of the action plan. The aim of the Special drive is to enhance the overall efficiency in the check posts and to step up the tax collection. The procedural formalities in the check posts shall be streamlined so that no Goods carrier with full and vivid documents shall be laid up in the check posts for more than two hours. The documents shall be electronically recorded and transferred to the respective offices then and there. This will enable the concerned officers in various districts / circles to cross check with the returns filed by the traders. This will definitely enhance efficiency and step up tax collection. The smooth traffic, transparent transfer of records, periodic reviews and social audit shall certainly bring down corruption. On successful completion of the special drive, it is envisaged that certain standard can be fixed and the model can be replicated elsewhere.

2) In the meeting held by the Honourable Minister for Finance on 28.7.2007 at Palakkad with officials of Commercial Taxes department and various other departments, it was decided, interalia, to overhaul the entire system of operation of the Check Posts and Intelligence Squads in Palakkad district for the above purpose. There are a number of checking stations without adequate sanctioned strength of staff. The number of counters in Walayar check Post has also to be increased to meet the heavy traffic. The existing staff strength is inadequate for the smooth functioning. To overcome the difficulty it has been decided to select fresh personnel from the department all over the state and induct them to man the Check Posts and Intelligence Squads in Palakkad district for a period of 6 months. In addition to this sufficient officials will be posted on working arrangement. The intention is to achieve the objective of a two-hour turn-around time for vehicles passing through these Check Posts.

3) In the circumstances, Government are pleased to accord sanction for the posting of officers to Palakkad and out of Palakkad district as per Annexure I to XI. All persons posted to Palakkad shall report for two days in-house training at KILA, Mulamkunnathukavu, Trichur, at 10AM on 4.8.2007. The new personnel will be trained for two days at KILA on 4th and 5th August 2007. Hands on training in data entry would be given to them on 6th August at Palakkad in KVATIS by CMC Ltd. They will assume their new stations on 7th August and familiarize themselves with Check Post operations. The new personnel will assume full operational efficiency from 15th August 2007. On

conclusion of their assignments they will stand reverted to the stations from which they were taken. Social audit by all stake holders such as Lorry Owners, drivers, dealers, elected representatives will be organized every month to review the operations.

4) The staff selected for the operation would be provided accommodation at Government cost in Palakkad district at various locations, since the period of stay in Palakkad is only for a limited period. Apart from the quarters, attached to Check Posts at Nadukunnu, Meenakshipuram, Govindapuram, the quarters offered by Malabar Cements, ITI, Shikshak Sadan and Forest Training Institute will also be used. The Commissioner of Commercial Taxes is authorized to expend necessary amount for doing up unused quarters, if any. The Commissioner of Commercial Taxes is also authorized to expend amounts for provision of cots and beds and food to the staff at the Check Posts at Government expense.

5) The staff will also be provided transportation at Government cost and from the place of work to the place of stay during the period of their stay to prevent loss of time and because the places of stay are far from the place of work.

6) The staff shortage in other districts caused on account of posting of clerks and peons on working arrangements to Palakkad district will be solved by engaging daily wage hands. The Commissioner of Commercial Taxes is authorized to engage daily wage employees, if found necessary.
